This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of April 2021, remitted to the City in May 2021.

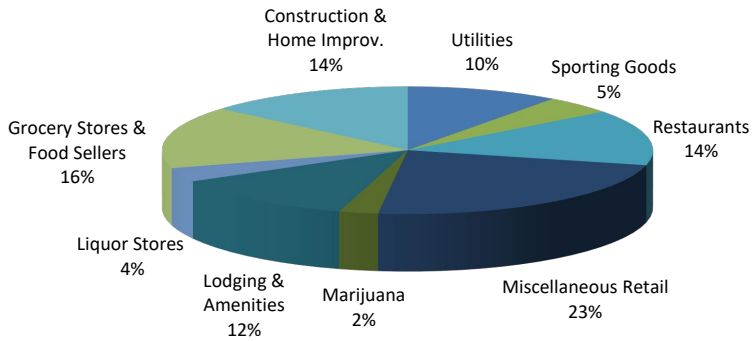
Sales Tax

 Year-to-date total sales tax collections are 16.69% higher than those of 2020 year-to-date.

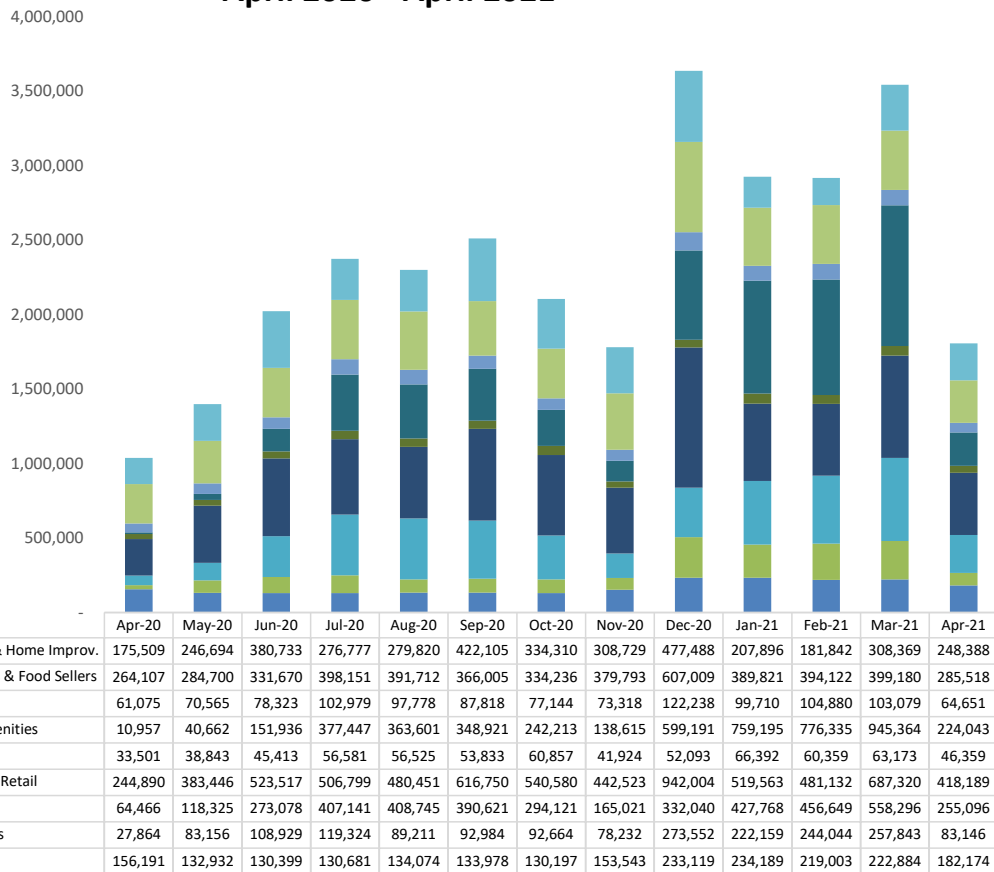

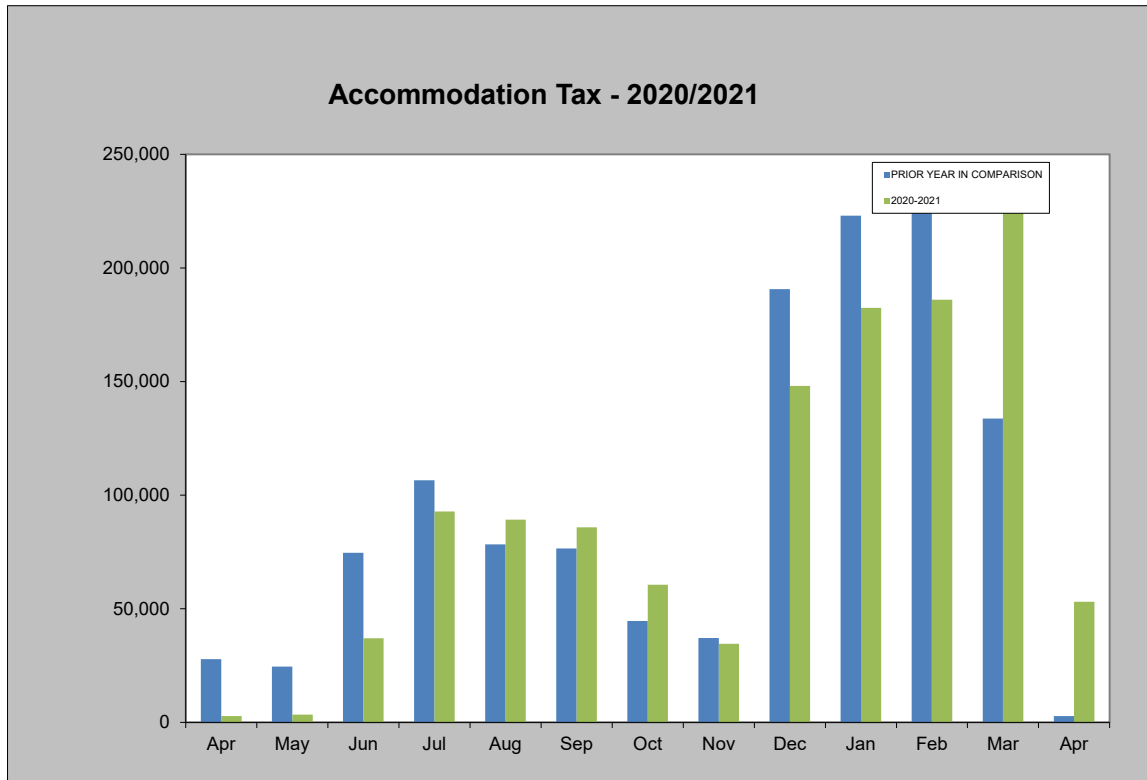


Accommodation Tax

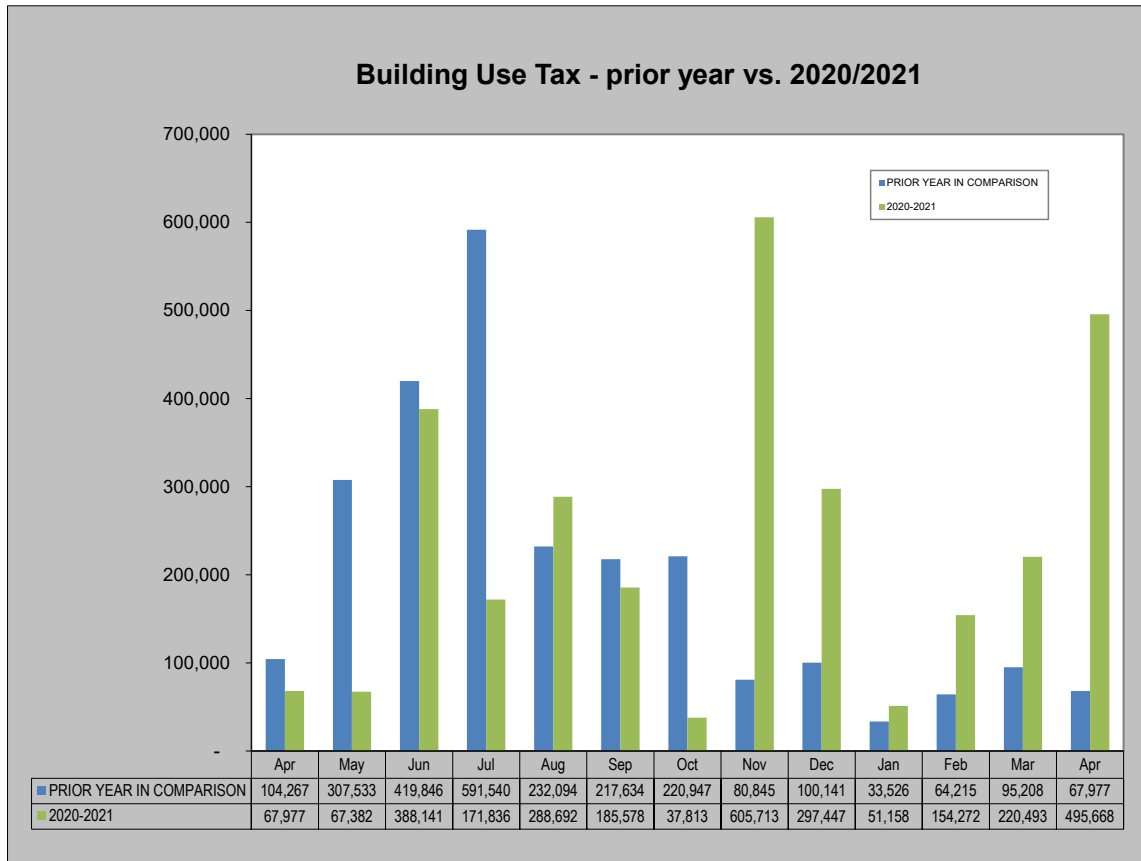


Building Use Tax

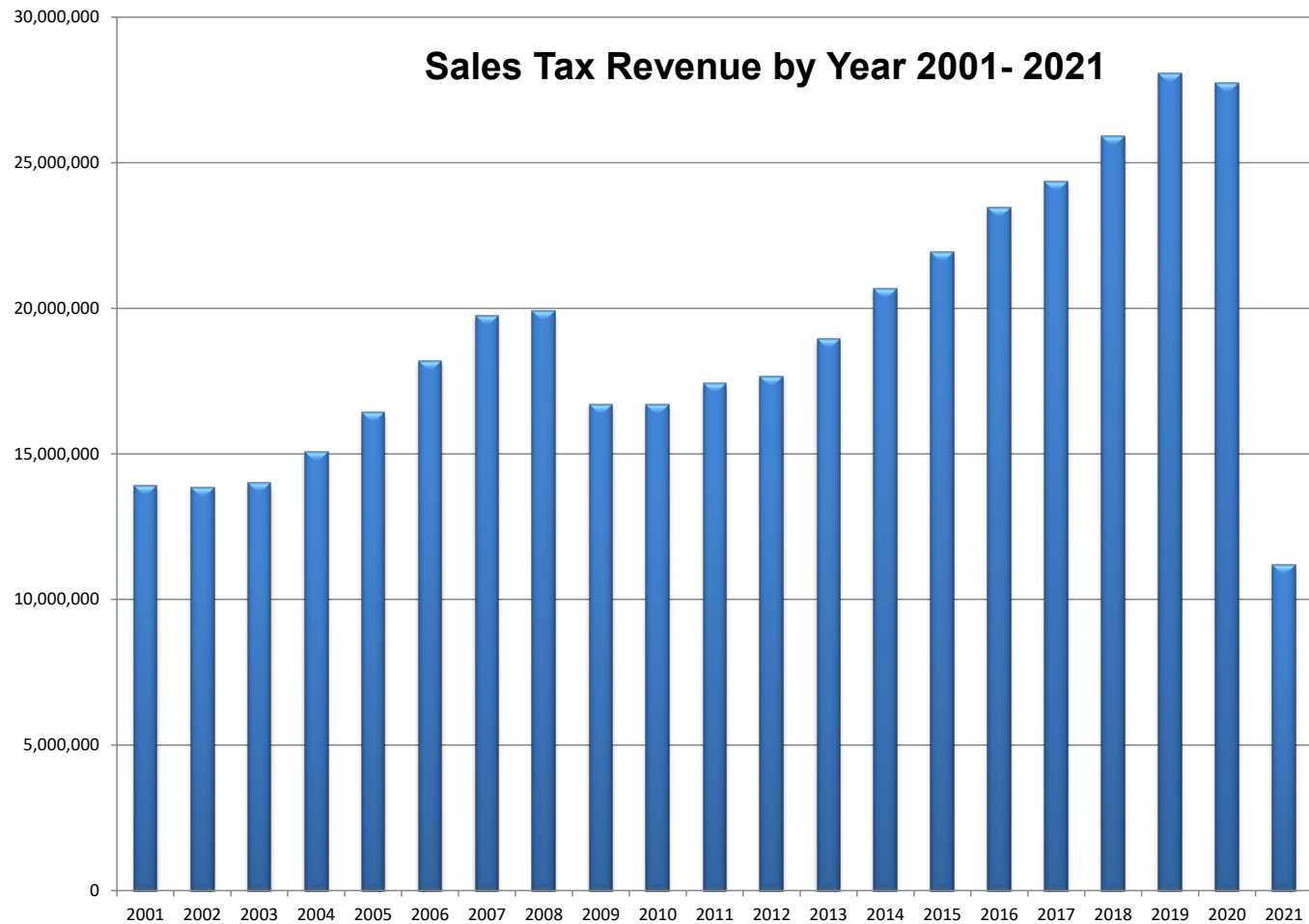
April 2021 building use tax collections increased by 629% compared to April 2020.
