Describe the steps taken to resolve the violation(s), and the anticipated resolution date:

The Colorado Department of Public Health and Environment (CDPHE) calculates a Locational Running Annual Average (LRAA) of the last four quarters at four designated sites within the District's distribution system. Since the results at 2 of our 4 testing sites were above the MCL in the First Quarter (January – March), a bubble effect was created making it difficult to quickly lower the LRAA below the MCL level of 60 ug/L.

The District took immediate corrective measures to flush the distribution system mains in the affected areas and an improved routine flushing program has been implemented in order to reduce the water residence time in sections of our water mains that may be vulnerable to HAA5 formation.

Sample results for testing in Quarter 1 of 2022 indicate that the LRAA is no longer above the MCL level of 60 ug/L.
