- 21. General architectural description:

This is a single-story building of wood frame construction. It is supported by a poured concrete foundation, and its exterior walls are clad with beige color stucco, covered with silver corrugated metal along the top of the wall surface. The roof is flat, with widely-overhanging eaves and with an extended eave on the façade (northeast elevation) which covers a front patio and sidewalk. The underside of the eaves are stained in knotty pine, while the eave edges and heavy wood rafters are painted dark blue. The building's asymmetrical façade faces toward Yampa Street. The northwest end of the façade contains a painted white glass-in-wood-frame entry door, and a set of paired single-light fixed-pane display windows. One of these windows features the following advertisement in yellow letters painted on the glass: "YOUR TYPICAL NAWLINS SANDWICH SHOP." Neon signs advertising "BUDWEISER" and "ABITA BEER" hang in the other window. The southeast end of the façade is penetrated by a single-light fixed-pane window, with a painted blue wood surround, flanked on either side by a single-light casement window, with a painted white wood frame and painted blue wood surround. A painted white glass-in-wood-frame door on the southeast elevation opens onto a covered outdoor dining area. The northwest (side) elevation is penetrated by a band of three large 1x1 horizontal sliding windows, and by a single-light fixed-pane window, all with painted white wood frames and painted blue wood surrounds. A horizontal sliding glass bypass door enters the southwest (rear) elevation.

22. Architectural style/building type: Mid-Twentieth Century Commercial Building

23. Landscaping or special setting features:

This property is located on the southwest side of Yampa Street in the block between 7th and 8th Streets. The Yampa River flows southeast to northwest along the rear (southwest) property line. A concrete paved patio area and sidewalk are located in front of the Sunpie's Bistro building's northeast elevation (facade). A concrete paved outdoor bar and dining area, covered by a flat corrugated metal roof, is located adjacent to the building's southeast elevation. An uncovered outdoor dining area extends behind the building to the river.

24. Associated buildings, features, or objects:

Tube Shack

Located southeast of the Sunpie's Bistro building, this wood frame structure features a rectangular plan composed of a gabled section and a shed-roofed extension. The exterior walls are made of stained brown vertical wood siding, and the roof is covered with corrugated metal. The roof eaves are closed. The northwest elevation contains two open bays. A green corrugated metal garage door on the northeast elevation opens onto a short brick-paved driveway which extends to Yampa Street. The upper gable end facing Yampa Street on the northeast elevation displays the following text:

Construction history (include description and dates of major additions, alterations, or demolitions): Routt County Assessor records list 1954 as this building's year of construction, and the building's address (735 Yampa Street) appears in the earliest-available (1956) telephone directory for Steamboat Springs. Its original use was as Dorothy's Greenhouse which later became Steamboat Floral and Greenhouse. Photos of the building from that time period were not uncovered, so it is difficult to determine it changed when it was converted into a restaurant in the 1980s. A greenhouse structure, located northwest of this building, was razed when this building was converted into a restaurant.

35. Historical background:

The river side of Yampa Street in this area remained undeveloped until the 1950s, although the Steamboat Fish Hatchery, and later the Steamboat Yacht Club, were located not far to the west. Constructed as "Dorothy's Greenhouse" circa 1954, this was the first building erected on the river side of Yampa Street in this block. Originally owned by Dorothy Wither, this business later became "Steamboat Floral and Greenhouse." Born in northwestern Colorado circa 1904, Dorothy was the daughter of venerable Steamboat pioneers Archie and Pearl Wither. Natives of Scotland, Archie and his brother George Wither founded the A. & G. Wither general merchandise store in Hahn's Peak in the 1890s before moving the store to Steamboat Springs in 1901. Dorothy Wither also owned and operated a women's clothing store, named the "Dorothy Shop" at 821 Lincoln Avenue from circa 1957 to the early 1980s. (For further biographical information on the Wither family, please refer to the inventory forms for 440 8th Street (5RT1065), and 821 Lincoln Avenue (5RT1029).

In the early 1960s, Dorothy's Greenhouse was renamed "Steamboat Floral and Greenhouse." The business existed at this location until the 1980s when it moved to 435 Lincoln Avenue and was renamed "Steamboat Floral and Gift." This building, meanwhile, became the home of "Yampa Blue" a small bistro which offered gourmet coffees, lunch, and imported gifts. For the last several years, 735 Yampa Street has been home to "Sunpie's Bistro" which offers Creole and Cajun cuisine.

42. Statement of significance:

This building is historically significant for its association with commercial development along Yampa Street during the post-World War II period. Built as a floral shop, circa 1954, this was the first commercial building located in this block on the river side of Yampa Street. It derives additional significance for its early association with Dorothy Wither who made notable contributions to Steamboat Springs' history. The building's historic and architectural significance is probably not to the extent that it qualifies for listing in the National or State registers; it does qualify for local landmark designation however.

43. Assessment of historic physical integrity related to significance:

This property displays a reasonably high level of physical integrity, relative to the seven aspects of integrity as defined by the National Park Service and the Colorado Historical Society - setting, location, design, materials, workmanship, feeling and association; although, it has undergone some alterations as it was converted from a floral shop into a restaurant in the 1980s. Most of these alterations are to the interior. The extent of exterior alterations are unclear.


