The undersigned applicant hereby affirms that refuse collection and transportation activities it conducts within the City of Steamboat Springs conform to the following requirements:

Applicant hereby agrees to indemnify the City against any and all suits, claims, demands, and costs, including attorney fees, arising out of, or claimed to arise out of, applicant's and applicant's customer's use of City rights of way for the collection and transportation of refuse.

Applicant has obtained and shall maintain a policy of public liability insurance insuring the City against any and all liability arising out of applicant's and applicant's customer's use of City rights of way for

the collection and transportation of refuse. Policy limits are in an amount not less than \$1,000,000 per occurrence and in aggregate. The policy names the City of Steamboat Springs, its officers, and employees as additional insured. The policy provides that the policy may not be cancelled or its terms modified without thirty days written notice to the City.

Applicant has obtained and shall maintain Worker's Compensation insurance as required by the Labor Code of the State of Colorado and Employers Liability Insurance

Applicant has obtained and shall maintain General Liability insurance with minimum combined single limits of \$1,000,000 each occurrence and in aggregate. The policy includes the City of Steamboat Springs, its officers and its employees, as additional insured, with primary coverage as respects the City of Steamboat Springs, its officers and its employees.

Applicant has obtained and shall maintain Comprehensive Automobile Liability insurance with minimum combined single limits for bodily injury and property damage of not less than \$150,000.00 per person in any one occurrence and \$600,000.00 for two or more persons in any one occurrence, and auto property damage insurance of at least \$50,000.00 per occurrence, with respect to each vehicle used in applicant's refuse hauling operations. The policy includes the City of Steamboat Springs, its officers and its employees, as additional insured, with primary coverage as respects the City of Steamboat Springs, its officers and its employees.

Applicant shall comply with all applicable federal, state, and local laws and regulations. Applicant shall comply with the Americans with Disabilities Act as applicable to all aspects of applicant's operations, including the provision of drop off recycling services.

Applicant shall comply with the provisions of Division 1, Article II, Chapter 19 of the City of Steamboat Springs Revised Municipal Code regarding the provision of recycling services. Applicant must follow City Municipal code, Per Article III, Section 19-101, (C)(E)(F)(G) Bear-resistant container, dumpster, or enclosure required.
